WAIVER OF LIABILITY

Pet Paradise Animal Hospital Inc, DBA Pet Paradise Animal Hospital and Resort (hereafter referred as Pet Paradise) and the owner of the dog(s) to be admitted into boarding/daycare (hereafter referred to as Owner) hereby agree as follows:

(INITIAL ALL LINES):

_____ Owner certifies that to the best of his/her knowledge, the dog meets all of Pet Paradise requirements:

(a) Up to date with the following vaccines:

Rabies, Bordetella, Distemper (DHPP), Leptospirosis, K9 Influenza (H3N2)

(b) Spayed or neutered if older than **8 months** of age

(c) Negative Parasite Screening within the **last 6 months**

(d) Heartworm Test within the **last 6 months**

(e) Current in heartworm/parasite/flea/tick prevention.

(f) Owner further certifies that the dog is in good health, not having been recently exposed to any contagious canine illnesses prior to any future stays at Pet Paradise boarding/day camp for a minimum of 10 days.

_____ In admitting the dog to boarding/daycare at Pet Paradise, Owner understands and agrees that Pet Paradise, its officers; owners, employees and agents have relied upon Owner's representations that the dog is in good health and currently vaccinated and Owner's representations regarding the dog's behavior history.

_____ Furthermore, Owner understands that no vaccination offers 100% protection from any disease, and that exposure to kennel cough is still possible even if the dog has received a Bordetella vaccination.

_____ Owner is aware and understands that Pet Paradise performs a complimentary technician exam on every dog before being admitted to Day Camp and/or Boarding. In the event of any findings the Owner will be contacted immediately to discuss necessary treatments. If fleas or ticks are found on your dog(s) he/she will be treated immediately at Owner's expense and dog(s) will not be admitted to Day Camp and/or boarding until Pet Paradise Veterinarian clears him/her and Pet Paradise is hereby released from all liability related to treatment and expense relating thereto.

_____ Pet Paradise will exercise reasonable care of the dog during its stay. Owner does acknowledge and he/she understands that their dog will co-mingle with other dogs, and that as a result their dog could incur small cuts, scrapes, or other minor injuries in the course of normal dog play. In consideration of these services, Owner expressly waives and relinquishes any claims against Pet Paradise, its officers, owners, employees and agents, relating to services provided pursuant to the Owner's dog, except those claims arising from willful misconduct by Pet Paradise, and further agrees to indemnify Pet Paradise against all such claims.

_____ Owner further understands and agrees that in the event of an emergency, Pet Paradise is authorized to provide emergency veterinary care as Pet Paradise Veterinarian deems necessary and Pet Paradise is hereby released from all liability related to treatment and expense relating thereto.

_____ Owner agrees to pick up his/her dog by 12:00pm from boarding and by 5:30pm from Day Camp. Owner understand that he/she will be charged a late check-out fee of \$10 for any dog not picked up by designated check-out times. An additional \$35 for overnight care will be added if the dog is not picked up by 6:00pm. Dogs not picked up by 6:00 pm will be assigned a boarding suite in our facility and can be picked up the following morning. No dog will be allowed to be picked up past 6:00 pm (M-F), or outside Pet Paradise office hours. If dog(s) are not picked up within 3 days, or if Pet Paradise does not receive contact from Owner during that period, the dog(s) shall be considered abandoned and Pet Paradise will place dog(s) at Owner's expense, as Pet Paradise deems appropriate. Owner further agrees to release, hold harmless and indemnify Pet Paradise for any claims relating to the transportation and kenneling of the dog(s) should Owner fail to pick up the dog for any reason prior to closing.

_____ Owner further agrees that in the event that Pet Paradise should observe/suspect that his/her dog may appear to be ill in any way, as determined by Pet Paradise, its Resort staff, or administration, Pet Paradise will require the veterinarian to verify the health status of the dog before allowing the dog to return to the Day Camp. **No refund shall be issued for unused pre-paid Day Camp days.** Owner shall be responsible for picking up the dog within a reasonable period of time on the same day, after being notified by Pet Paradise that his/her dog needs to be removed from Day Camp. The dog will not be allowed to return to Day Camp until a Veterinarian has provided written health clearance.

_____ Owner gives permission for photos and videos of their dog(s) to be taken by Pet Paradise staff for use in advertising and promotional material and media. Pet Paradise agrees not to sell or distribute these photos/videos to any third party.

_____ Owner further agrees to the following conditions regarding pre-paid cards; Pre-paid Day Camp card are **non-refundable.** Pre-paid Day Camp cards expire one year from the date of purchase. Unused days will be forfeited and will not be refunded or honored after the one-year expiration period.
